## WHAT WE DO

The Health Care Access Project® (HCAP®) of Legal Services of New Jersey helps low-income individuals throughout the state who cannot get proper health care for themselves and their families.

HCAP provides free legal advice and representation for adults and families with such issues as eligibility for insurance coverage and getting necessary medical care in the following programs and more:

- Medicaid
- Medicare
- NJ FamilyCare
- PAAD
- Charity Care
- COBRA
- Hill-Burton
- Insurance
- Health Centers
- WIC
- Catastrophic Illness in Children
- Assistance for the Uninsured



## HCAP CAN HELP WITH THESE TYPES OF PROBLEMS

- You were denied or terminated from Medicaid and NJ FamilyCare.
- You have Medicare Part D, but you can't get the prescriptions you need.
- You are eligible for Charity Care, but you are getting medical bills.
- You are not eligible for Medicaid or NJ FamilyCare but need medical care.
- You are in an HMO, but you cannot get an appointment you need.
- You have Medicaid, but you have no transportation to your doctor's office.
- You need help to stay in your home instead of moving to a nursing home.
- You cannot afford your prescriptions.
- Your home health aide or medical day care hours have been cut back.
- You have a mental illness but cannot get coverage for the needed treatment.
- You need a wheelchair, hospital bed, or other special medical equipment, but insurance will not pay.
- You need help applying for Medicaid or NJ FamilyCare.
- Most other health-related issues.



## HOW CAN WE HELP?

HCAP has been helping low-income individuals with health-related legal issues since 1999. HCAP has an experienced staff of attorneys and paralegals with interpreters and translation services available.

HCAP provides appropriate legal intervention with providers and program officials to resolve issues of coverage and access to medical care.

HCAP provides direct advice to clients about their eligibility and legal rights in such programs as Medicaid, NJ FamilyCare, and Medicare.

HCAP provides necessary direct representation in legal matters of appeal such as Fair Hearings and Grievances.

HCAP also utilizes the services of social workers at Legal Services of New Jersey to provide appropriate assistance for clients.
