


## 2018 ANNUAL REPORT

In 2018, LSNWJ provided legal assistance in 4,190 cases affecting essential needs, including 655 cases opened in prior years for which work continued. LSNWJ's work in 2018 helped 8,153 low-income people, including 2,566 children.



Legal Services of Northwest Jersey is a nonprofit law firm serving people living in poverty in Hunterdon, Morris, Somerset, Sussex and Warren counties. The work of LSNWJ is vital to the efforts of people living in poverty to maintain safe and affordable housing, gain sustainable income to escape the ravages of poverty, access quality health care, secure family stability and personal safety, and live with dignity in the community. In 2018, 99% of clients provided with full legal representation by LSNWJ pursued legal remedies and 87% were successful in meeting their essential needs.

LSNWJ received a Legal Services Corporation Pro Bono Innovation Fund grant for our Achieving Justice through Pro Bono Innovation project. We engaged the Board, staff, volunteers and other stakeholders, in conducting a thorough assessment of our pro bono program and we are improving our program to meet the critical needs of our clients while providing a rewarding experience for volunteers. We have implemented a mentoring model in our tenancy projects, held training on substantive law, skills, professional responsibility and cultural competency, created resource binders, and improved communication between LSNWJ and its volunteers. LSNWJ will continue this work to further integrate pro bono into our mission and strategic goals.





# LSNWJ 2018 Expenses

In addition, LSNWJ invested \$119,214 in the Michael Weiner Justice Center and other building improvements and equipment. More than 92% of LSNWJ resources are used to support program work. Management, administration, and fundraising, although a small portion of the overall budget, are critical to maintaining focus on mission, assuring quality, meeting grant requirements, and securing new funding.

Contributed services expand our capacity to serve those in need. In 2018 volunteer attorneys provided free legal assistance in 223 cases, donating 1900 hours of their time to the cause of equal justice.

In-house volunteer attorneys provided 560 hours of volunteer service. The Partnership for Justice volunteers from Merck, Reed Smith and Sanofi provided 420 hours of legal assistance to tenants facing loss of their homes and vulnerable seniors and others in need of life-planning assistance. The Veterans Justice Initiative, a partnership of LSNWJ, Merck and Lowenstein Sandler, provided veterans with 445 hours of service. The balance of volunteer time was provided by individual private attorneys, many of whom are solo practitioners or in small law firms.
